



A Report on the 62nd SCCA National Convention

The Northern New Jersey Region was well represented at this year's National Convention – the 62nd annual gathering of our club. For the fourth straight year the convention was held at the Westin Crown Center in Kansas City, Missouri, a city only about fifty miles away from Topeka, Kansas where our national headquarters are located. Making the trip were Assistant RE Mike Feno, Trustee Joe Russell, members Leslie & Bob Dowie, Lenore & Dave Panas, Terry & Peter Roberts, Katy & Kristian Skavnes and Nancy & Walter Huber.

Pre-convention meetings were already happening all day long on Wednesday, Feb 1St. The Board of Directors were meeting as well as the various activity Boards – the Club Racing Board, the Solo Events Board, Rally Board.... I saw NNJ's Bob Dowie (CRB member) for just a moment on Wednesday as he was shuttling from one meeting to another. And I also saw – very quickly as well – our Area I Director and new Chairman of the Board of Directors, **Bob Introne** and the club's acting president and outgoing Chairman, **Gary Pitts**. Gotta give all these folks lotsa credit. They really put in whole bunches of time and work for the club!

The actual convention sessions got under way on Thursday, the 2nd. Mike Feno's flight was scheduled to touch down at the airport at around 11 o'clock on Thursday morning. Expecting that he might not get out of the airport quickly enough to make it to the first of the sessions for Regional Execs by 12:30, I had arranged permission to sit in on the session for him. But just as the session was about to begin, Mike arrived. I suspect that the hotel's shuttle driver, seeing all the race oriented folks coming to the hotel, must've figured he had to show off his driving prowess to the folks arriving for the convention.

The Annual Meeting was later in the afternoon. The results of elections in several Areas were announced and the recently elected Directors were installed. Outgoing Directors were recognized for their service. Gary Pitts, the outgoing Chairman of the Board, had also doubled as the interim president of the club while the selection and hiring of a new president was proceeding. Gary, a former member of NNJR, was thanked for having handled these additional duties.

The Annual Meeting is also the session where the membership receives reports on the status of the club's various areas of activity. Representatives from each of the club's divisions give their reports. The club's wholly owned subsidiaries also give status reports. These reports will appear in *SportsCar Magazine* in another month and you can read them then.

Also at this session we were introduced to the recently selected president & CEO of our club, **Jim Julow**. He will take over at the club's helm in mid-March. I had been introduced to Jim by Area 13 Director **Duck Allen** on Wednesday evening but my first opportunity to really talk with him was at the Chairman's Cocktail Party on Friday evening. He seems to be a very interesting and personable gentleman. I hope his friendly nature extends to capable business acumen. Here's hoping he will carry forward the excellent work which was begun by **Steve Johnson**.

On Thursday evening the day concluded with a Welcome Reception in the grand hall of the Union Station located across the street from our hotel. We had a great time eating, drinking and socializing with friends while a five piece jazz combo played.

The Leadership Breakfast jump-started things on Friday morning. Among the awards given were those for Best Regional Publications. Our region's *Pole Position* newsletter was awarded second place in the Large Region category. Congratulations to our editor **Maureen Coultas**. The last time that *Pole Position* was recognized with an award was almost twenty years ago when **Joe DeLuca** was editor. Once again our newsletter's masthead will contain the words "award winning."

More seminars continued the morning's activity. At the Rally/Solo Awards Luncheon on Friday several more awards were presented. The afternoon was filled with more seminars and panel discussions.

Saturday morning began with the Club Racing Board Town Hall meeting. Then, in the last session before lunch, the third edition of the acclaimed Safety Symposium began with presentations by Hubert Gramling and Dr. John Melville who spoke on safety and aspects of crash test data collection.

The Club Racing Awards Luncheon was highlighted by the presentation of the Kimberly Cup, the Jim Fitzgerald Rookie of the Year Award, as well as several other prestigious SCCA awards. However, the pinnacle of this awards luncheon was when Northern New Jersey Region's own **Kristian Skavnes** was presented with the Mark Donohue Award by none other than RRDC President and banquet keynote speaker **Bobby Rahal**. This award is given annually by the Road Racing Drivers Club to the driver who demonstrates ability, competitiveness and success at the *SCCA Club Racing National Championship Runoffs*. How appropriate that this award, which is named in honor of a former member of NNJR, be earned by a current member. Kris' wife, **Katy**, looked on with pride as the award was presented and Kris spoke his words of acceptance.

A listing of all the recipients and the awards which were presented at all the ceremonies throughout the convention is available at <u>www.scca.com</u> and will also be published in the next *SportsCar* which you will be receiving.

Saturday evening's Hall of Fame Induction Banquet was the finale of the convention. Five members were added to last year's ten inaugural inductees. All five are well known to the NNJR membership and one, Mark Donohue – as mentioned earlier — was a member of NNJR and began his racing career with our region.

It was announced that the SCCA National Convention will begin a three year run at the Crowne Plaza on the Riverwalk in San Antonio in 2007. The last time the National Convention was held in San Antonio was 1992. I can tell you that the '92 convention in San Antonio was among the best I ever attended and the city was a great place to visit. Make your 2007 plans and hold the dates of January 31st thru February 5th open. Better yet, take an additional several days – come early... stay later... do both – to tour the area!

2005 Pine Barren Express (PBX) Road Rally November 19, 2005

Jim Heine of Sportscar Magazine said the PBX Rally has "far outdistanced every other divisional or national on the 2005 calendar". Jim was speaking, of course, about the number of entries. Personally, I feel that there are a large number of other features that enter into our success.

We had 54 teams that showed up to run (and ran). Five of those teams came from our region. I would like to thank those folks for their support and congratulate them on their wise choice to run. They certainly know a good time when they see it. Seven teams from Philadelphia Region ran (they're pretty sharp too). Four



teams from South Jersey, four teams from New England and three teams from Virginia & Maryland. There were four other teams from other Regions. Also, not all entries listed club affiliations, so there could have been more. Anyway, the SCCA was well represented in this year's PBX. There were also 2 teams from North Jersey Porsche Club.

What kind of vehicles ran? Well, 21 Subaru's, five Mitsubishi's, four Toyota's, four Jeep's, four Chevy's (2 Tahoes, a Suburban & ZR2), two GMC's, two VW's, four Fords (a Mustang & 3 SUVs), one Nissan, and a variety of other cars which included a Plymouth Voyager, a Dodge Dakota, a Saab 9-2x, an Olds Alero, a BMW 325IX, an Infinity FX45, a Buick Rendezvous, and a Jag X-type. Admittedly, a few of these vehicles exceeded width and/or height limitations and maybe one or two could have used an inch or two more of road clearance, but I heard no complaints. In case you're curious as to what is generally accepted as the most practical type of vehicle the answer is: not too small, not too large and with all-wheel (or 4-wheel) drive.

How well did our SCCA folks do ? Frank Bochanski & Peter Chezik from South Jersey region took 1st overall. 2nd overall & 1st in Equipped was Mark Johnson & Frank Beyer from Central New York region. Jim & Jeff Wakemen from North Jersey & South Jersey regions respectively took 3rd equipped. Jeff Lloyd & Walt Morris from South Jersey region won 1st Limited (Class B). 3rd Stock (SOP) was won by Dave Horoschak & Darren Hess from Philadelphia region. 2nd Novice was garnered by Andrew Dunkinson & Peter Merrick from North Jersey region. If you're interested in scores, they're posted on the RVSCC.COM website. I would note that we drew entrants from every state starting from Virginia north to Maine with one exception – Vermont !

The Rally itself is noted for its **roads**. They vary from very wide to extra narrow, from low clearance to overhung with trees. They're straight & twisty, level & slightly hilly, short and very long. The roads have one thing in common: 90% **unpaved**. Their surfaces are comprised of either white "sugar" sand, (which can be firm and grassy to loose), or hardpack (yellow sand with a mix of yellow clay). Most of the roads are approximately 1.5 lanes wide (usually sugar sand). Some are about one lane wide (sugar sand) and there are some two and three lane wide "hardpack roads". Pictures on the RVSCC's PBX website show many of



these roads in all their glory. There were about 35 miles of excellent paved roads (State & County routes) in the '05 PBX and almost all of them were used as transit zones (no Checkpoints). In addition, the Odometer Checkleg and transit zone (to the Rally finishing point) are excellent paved roads (also county routes). Where do we find all these unpaved roads ? Why, in the State Forests! The Rally ran in **3 counties, 17 Townships and 5 State Forests**. The Rally passed through Fort Dix and past a number of important historic sites. Some 30 workers manned Registration, Checkpoints, scoring team, lead car, sweep car and other

activities. Some Checkpoints were more than 30 miles apart and were manned by one team (work on that one for a while). Checkpoints were all closed (contestants didn't stop at them) and were not visible until you were right on top of them (surprise Surprise !). In addition, we had workers from a farm repairing 2 roads one day before the Rally, State Forest road crews grading one major road 2 days before the event and one Township Road Crew repairing and raising a section of road 2 feet (a week before the Rally) – <u>all at our request</u>. And only 4 days before the Rally, I had a road collapse in the cranberry bogs and had to drive 60 miles down to the bogs the next day to work up a new route because the original road couldn't be repaired in time.

Everything we do is for the benefit of the contestants. The Route Instructions are a type which are the only type usable for roads with no clues to follow. After all, there are no signs in the Forests, no buildings, no street lights, and pretty much every pine tree looks like every other pine tree. Mileages are measured to the 1000th when we set up the rally and are measured at least 3 times after that. We get permits to use every foot of unpaved roads on the Rally. We get permits from the State Forests (which will cost more next year). We get permits from the State & Federal DEP (which aren't free either). We get written permission from the State Police **and from every township we pass through** (some of whom charge a hefty "parade" fee). The route is checked by both experienced Rallyists and by at least one inexperienced team. The logistics for the PBX are probably the most complicated for any TSD rally in the country. We have never had a validated protest involving an error in our Route Instructions, timing or General Instructions (and remember the PBX is part of 3 different SCCA Championship Series-National, NEDIV and Mid-Alantic).

If you haven't been on a TSD Rally, don't shy away from this one. There are always a number of Novices running the PBX, and they do okay. The 2006 Northern New Jersey Region Road Racing Championship for the Victoria Cup Presented by Victoria Motorsports Champion Receives \$250.00 and the Victoria Cup presented by Victoria Motorsports, Inc.

Eligibility: In order for a Competitor to be eligible to earn points and compete for the Championship he/she shall be a NNJR member in good standing, enter and compete in all three NNJR Regional Races in 2006 [Double Regional at Pocono on 5/13-14 and the Regional at Lime Rock on 8/4-5]. A driver shall be classified as a starter or have qualified in each of the three races to be considered eligible for the championship. Failure to be a starter or to qualify for each race will render a competitor to register or forward results sheets. All drivers will tally all points and it is not necessary for a competitor to register or forward results sheets. All drivers will be considered for the Championship by virtue of entering the first race at Pocono on 5/13/2006. The Champion will be the Driver who satisfies the aforementioned criteria, accumulates the most points and attends the NNJR Annual Dinner and Awards Banquet to claim the trophy and \$250.00; second place \$100.00; and third place \$50.00. In the event the Driver with the highest accumulated points meeting the aforementioned eligibility criteria does not attend the Banquet then the championship trophy and prize money will be awarded to the Driver in attendance with the most accumulated points meeting the eligibility criteria.

Points: Each competitor that finishes pursuant to the Official final results will be awarded points as follows:

In addition, one additional point will be awarded for each car a competitor finishes ahead of, including cars that are classified as DNF"s, (i.e. if a competitor finishes 3rd in class and there were 9 cars in his/her class the driver will receive 31 total points for that race regardless of whether all 9 cars are eligible to compete for the Championship).

In the event of a tie the winner shall be decided based upon the number of first place finishes in class, then if necessary, the number of second place finishes in class, etc.

Judges: The NNJR Club Racing Committee shall act as the judge for this Championship and shall decide all matters including ties and disputes in their sole discretion.

2006 New England Challenge Series Schedule

(For immediate release – for more information, please contact Bob Lutz or John Merriman)

The schedule for the 2006 New England Challenge (NEC) series for Formula Ford has been set with 10 race events over 7 weekends. Based on driver feedback a major change has been made from 2005 in that both ends of Double Regionals will be counted as NEC events for 2006 rather than previous years where just the Sunday event was counted. A second Watkins Glen event was added to the schedule based on driver feedback. And finally, the Beaver Run event was moved to coincide with the National in June to avoid a conflict with Lime Rock in August.

The six race rule, wherein drivers count only their six best results, will likely be used by a number of drivers in 2006 with the expansion of the NEC series to 10 events. As in 2005, the Club Ford class will use the NARRC / MARRS spec tire rule; Club Fords running on soft tires will be grouped with FF for the purposes of NEC points and awards. Club Fords should continue to register for events according to the Supps for that event; the NEC coordinators, with help from the drivers, will track the Club Ford NEC class. The 2006 NEC schedule is:

The defending 2005 NEC Champions, Rod Kendall in CF and Doug Hobby in FF, will be back in 2006 to battle for the championship. Sponsorship for the 2006 series will be announced later in the winter as everything becomes firmed up. Last year we had an average participation of 16 FFs and a peak count of 26 cars at the 2005 Memorial Day event at Lime Rock Park, followed by 21 cars at Watkins Glen. Hopefully, the 2006 series will draw even better car counts.


