Race Report (CM, BO)

 BO, BF and CM discussed the possibility of a NNJR Majors in 2018, general option is that since the Run-Off in 2018 is on the West Coast a Pocono Majors run by NNJR would not be cost effective, but that a Divisional event might be. BO as asked Pocono to hold the Memorial Day weekend for NNJR. Future discussions are required. It was noted that

This program is funded by Club Racing and only applies to specialties associated with Club Racing, which includes Registration Activities.)

Social Media (BF)

• LSM has suggested to look into the Student Intern program at County College of Morris as a possible source to assist the Region with Social Media coverage. She will report back to the BOT and has agreed to act as the 'Facility Adviser' if the program is established.

Social Report (LSM)

- Annual Meeting LSM has agreed to Chair the 2017 event, she will look into holding it at Brio and include Dinner for
 those that would like to attend, possible open bar (1 or 2 hours pending on budget). Additional discussion occurred
 around presenting Year End Awards at the Dinner, including the Giltzow Awards, Blancuzzi Award, Driver of the Year
 Award, Rookie of the Year Award, Most Improved Solo Driver. Hopefully this will motivate members to attend the
 event.
- BO will Chair the Selection Committee for the 2017 Giltzow Awards. He will contact prior winners to make up the committee. The committee will be made up of three prior winners, including BO.
- BOT approved up to \$250 for PS to obtain a 'Keeper Award' for the prior Giltzow Winner (Darrell Anthony) and \$150 for a 'Keeper Award' for the 2017 Blancuzzi Award. (Short discussion concerning section for the Blancuzzi Award winner and a name was selected)

Solo Report (ML)

- Solo Program created an 'Unofficial Northern New Jersey Solo' Discussion group on Facebook, additional offline
 discussions need to take place between ML and BF on how it will be monitored by the BOT since it will reflect on our
 Region. Prior approval for the Facebook page was not obtained by the BOT
- Event #5 7/23
 - We had 144 drivers and had a net revenue of \$2,410
- Event #6 8/6
 - We had 130 drivers and had a net revenue of \$1,966
 - There was an incident at the event where a Focus RS lost control after the finish and hit a light pole. The car was totaled but there were no injuries or property damage to the site. An incident report was filed with the national office with all required supporting documentation. The Board discussed the need for improved communications for any future incident at Solo events. Being informed 48+ hours after an incident is not acceptable (this comment also holds true for any incidents that might occur at a Rally or Race). BOT feels that the RE must be contacted immediately in parallel with National Office and a copy of the Incident Report be forwards to the BOT@SCCA-NNJR.COM by Carbon Copy of the report being filed with National.
- Event #7 8/19
 - This is our next shared event with PCA. We'll be paying full lot rental price for lot E again, but we won't be paying SCCA sanction fees for this event. Registration is still a bit light, but that's probably due to a less than optimal weather forecast. ML assumes we should have a decent turnout since this is our last event before the national championship in Lincoln. Solo Program need to follow-up with PCA-NNJR about Insurance Coverage for Joint Events
- Event #8 9/16
 - Registration opens Sept. 1st.
- ML discussed additional equipment upgrades for 2018, he will present a budget and list of Items at the next meeting for review.

Rally Report (PS)

- Next event is August 26th, as of today there are 25 teams signed up for the event.
- PS and Joanne S. just returned from the Targa Southland Weekend, which is a 3 day combined Specialty Event hosted by SCCA National (Race. Solo, Rally). The rally went well and had 45 teams.
